Rapid Rehabilitation Success: LP's Journey to Recovery Patient Information:

• Age: 17 • Gender: Male • Weight: 126.4 lbs

• Diagnosis: Diffuse traumatic brain injury without loss of consciousness, initial encounter • Physician: Dr. Stefanie Ruffolo

Background: We are thrilled to share an inspiring story of resilience and rapid recovery, a story that could not have been possible without your support. This month's spotlight is on LP, a remarkable 17-year-old who overcame significant challenges following a traumatic brain injury. His journey from injury to recovery in just over two weeks is a testament to the power of comprehensive rehabilitation and patient determination, a journey of which you were an essential part.

Meet LP: LP, a 17-year-old male, was admitted to a Level 1 trauma center with multiple gunshot wounds (GSWs), resulting in penetrating brain injury, GSW left cheek, left frontal, left occipital intra-parenchymal hemorrhage, intraventricular hemorrhage, subdural hematoma. LP suffered a diffuse traumatic brain injury without loss of consciousness.

The Road to Recovery, An Interdisciplinary Approach: At Lakeview, we believe in a holistic, patient-centered approach to rehabilitation. LP's care team included specialists from occupational therapy, physical therapy, and speech-language pathology, all working together to create a tailored rehabilitation plan.

Progress: LP demonstrated significant improvements in gait, endurance, and overall activity tolerance. By the end of the week, he could walk with minimal assistance and complete more complex physical tasks with supervision.

Conclusion: LP's story is a powerful reminder of the potential for rapid recovery with the right support and motivation. At Lakeview, we are proud to be part of such life-changing journeys. Sometimes, we see miracles happen at Lakeview. With the patient coming in comatose to walking out to his brother's graduation, LP's is a story for the books and a great reminder of our staff's HEALING HANDS. I hope you all come to work filled with hope, enthusiasm, and gratitude for the lives saved and the lives you will be touching in the future. Transforming Lives with Dedicated Helping Hands Patient Overview: •Age: 60 Admit Date at Lakeview LTAC: April 6, 2024 Discharge Date: June 26, 2024 • Previous LTAC Facility: Kindred in Chicago Weight upon Admission: 568lbs ·Primary Diagnosis: Other malaise Physician: Dr. Mustansir Majeed AM's Extraordinary Journey to Recovery, Staff Going the Extra Mile: AM's story is just one example of the exceptional care provided at Lakeview's LTAC. Our team's dedication to patient-centered care, innovative treatment approaches, and relentless advocacy set us apart. We are proud to share AM's success as a reflection of our commitment to positively impacting our patients' lives. History of Present Illness: AM, a 60-year-old male with a significant history of morbid obesity, obstructive sleep apnea dependent on CPAP, lymphedema, and multiple other comorbidities, was admitted to Highland Park Hospital on February 28, 2024. He presented with decreased lower extremity strength, an inability to walk, and diarrhea with bloody stools. His condition required specialized care, leading to his transfer to Kindred's LTAC in Chicago before arriving at Lakeview. Initial Condition: Upon admission to Lakeview, AM was severely obese, weighing 568 lbs, with a BMI of 74.9. He was non-ambulatory and required extensive assistance with daily activities due to general weakness and limited mobility. His condition included chronic venous stasis ulcers, obstructive sleep apnea, and lymphedema. Innovative Interventions and Comprehensive Care: At Lakeview, we believe in going the extra mile to ensure our patients receive the best possible care. For AM, this meant developing a multifaceted treatment plan that addressed his unique needs. Our dedicated team of therapists, nurses, and physicians worked tirelessly to implement the following interventions: Going the Extra Mile: Advocating for Ozempic: AM's weight loss journey received a significant boost when our team recognized the potential benefits of Ozempic (semaglutide) for his condition. Despite the medication not being a standard requirement, our team wrote letters to his insurance provider advocating for coverage. While certainly not mandated, this effort stemmed from Lakeview's commitment to AM's health and well-being. **Medication Management:**

Ozempic Initiation: AM was started on Ozempic at Lakeview to assist with weight loss. The medication regimen included an injection of 2 mg every 7 days.

Other Medications: Besides initiating the use of Ozempic for weight loss, Lakeview continued to manage AM's existing medications, including anticoagulants, antihypertensives, and therapeutic management for pain and inflammation.

Remarkable Progress and Achievements: AM's progress at Lakeview's LTAC was extraordinary. The combined efforts of our multidisciplinary team and the inclusion of Ozempic in his treatment plan led to remarkable outcomes: Weight Reduction: With the introduction of Ozempic and a structured weight loss program, AM achieved a significant weight reduction, losing over 35 lbs during his stay at Lakeview.

Increased Independence: AM progressed from needing maximum assistance to performing many ADLs with minimal assistance or supervision. He became proficient in using adaptive equipment for bathing, dressing, and toileting. Enhanced Mobility: AM's ability to ambulate improved significantly. He went from being primarily bedridden to walking short distances with a bariatric walker and completing transfers with minimal assistance.

Strength and Endurance: AM's muscle strength and overall endurance improved, enabling him to tolerate longer therapy sessions and engage more actively in his rehabilitation program.

Self-Advocacy: Education on self-advocacy and self-care strategies empowered AM to take more control over his health and rehabilitation process. A Bright Future Ahead: AM's journey at Lakeview is a testament to the dedication, innovation, and compassion that our team brings to each patient. By going the extra mile and advocating for treatments like Ozempic, we were able to help AM achieve substantial weight loss and improved functional independence. As he transitions home, AM is equipped with the skills and confidence to continue his rehabilitation journey independently. Conclusion: The multidisciplinary approach at Lakeview, emphasizing personalized care and patient empowerment, played a crucial role in AM's successful rehabilitation. His journey highlights the importance of tailored therapeutic interventions in achieving positive outcomes for patients with complex medical needs.


